AMENDMENT.

CHARTER OF INCORPORATION.

We, the undersigned, comprising the Board of Directors of the Nashville Bible School, apply to the State of Tennessee, by virtue of the general laws of the land for an amendment to said Charter of Incorporation for the purpose of investing said corporation with the power to change its corporate name.

Pursuant to said power, and by virtue of this amendment, the corporate name is hereby changed from "The Nashville Bible School" to "David Lipscomb College".
