Mrs. A. R. Holton was suggested as a Bible teacher. It was moved, seconded, and unanimously pass that she be employed at \$100 per month.


Reports from J. E. Acuff and O. H. Boatright were filed with the Board.


In keeping with the instruction of the Chairman to spread a record of the stock held by the Nashville Christian Institute on the minutes of this meeting, the following list of stock is made:
